

# **Stoltzfus Structures LLC 24-25 Greenhouse Giveaway Official Rules**

## **1. Introduction**

STOTLZFUS STRUCTURES, LLC is offering the 2024-2025 Stoltzfus Structures LLC Greenhouse Giveaway. NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

## **2. Eligibility**

In order to be eligible for the 24-25 Stoltzfus Structures LLC Greenhouse Giveaway, the following criteria must be met:

- Giveaway is open to all legal residents of the 49 Continental United States and D.C., who are over 18 years of age. Void where prohibited or restricted by law.

One (1) Grand-Prize Winner will be randomly selected by Stoltzfus Structures LLC and/or their nominated representatives from the ten (10) finalists during a live Facebook video or

other broadcast by Stoltzfus Structures LLC at their option on or about February 28, 2025.

## **7. Site Preparation**

Stoltzfus Structures LLC recommends the following site preparations:

Our greenhouses include a pressure treated, 4 x 4 Southern Yellow Pine (SYP) base. All that's required is a level, well-drained area. A specially prepared site is not necessary unless you prefer that route.

The 'floor' of your greenhouse can be finished in a myriad of ways before or after delivery (concrete slab, pavers, bricks, gravel, mulch, etc.) Additional information or suggestion can be provided by Stoltzfus Structures if requested.

## **8. Delivery**

Delivery may be scheduled up to six months post the winner announcement. Stoltzfus Structures LLC will handle delivery of the greenhouse to the winner. Deliveries are normally made Monday through Friday between the hours of 6 am and 6 pm depending on customer location. Mileage is based upon the distance from Stoltzfus Structures LLC's facility, or affiliate facility, to the requested delivery location. Stoltzfus Structures LLC reserves the right to reschedule deliveries due to inclement weather, periods of excessive rain or other events beyond our control. Stoltzfus Structures LLC also asks that the Winner request delivery be rescheduled should the Winner believe inclement weather, soft ground or other conditions exist which would impede the safe delivery of the building or cause damage to the delivery truck or trailer or Winner's property or otherwise make delivery exceptionally difficult for the driver.

Fourteen (14) feet of clearance must be provided to the building site or delivery will be made to the closest acceptable site. Winner understands

that the trucks used to deliver buildings are heavy industrial trucks and, therefore, Winner warrants to Stoltzfus Structures LLC that the driveway of Winner is capable of holding the weight of the trucks and loaded trailer. In the event the driveway is damaged despite this warranty by Winner, Winner waives any cause of action against Stoltzfus Structures LLC or its subcontractors for any damage associated with the trucks and trailers of Stoltzfus Structures LLC or its subcontractors. Winner understands that it may be necessary for Stoltzfus Structures LLC or its subcontractors to drive across or through Winner's lawn, pasture or other ground. Winner also waives any course of action against Stoltzfus Structures LLC or its subcontractors for any damage caused to Winner's lawn, pastures, ground, fences, gates, structures, buildings, animals or other property whatsoever. Winner is responsible for towing charges incurred should the delivery truck or trailer become stuck.
